## **Introduction**

As prescribed in the Appendix of the FSA ( Financial Student Aid ) handbook:

In 1990, Congress passed the Crime Awareness and Campus Security Act (CACSA) amendments to the Higher Education Act of 1965 (HEA). Amendments to CACSA in 1998 renamed the law the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (the Clery Act) in memory of a student who was murdered in her dorm room. In 2013, Congress passed the Violence Against Women Reauthorization Act (VAWA), which included additional amendments to the Clery Act.

The Clery Act requires that all postsecondary institutions participating in Title IV student financial assistance programs disclose campus crime statistics and other security information to students and the public. The VAWA amendments added requirements that institutions disclose statistics, policies and programs related to dating violence, domestic violence, sexual assault, and stalking, among other changes.

This publication posted on the Central Valley Barber College's web page annually, each October 1<sup>st</sup>, and Central Valley Barber College's compliance with such requirement, intended for the information and safety of all students and staff.

## **Reporting Geography**

## **Crime Log**

Although Central Valley Barber College does not have a campus police department, the school has elected to maintain a crime log as outline in the Clery Act in the FSA handbook. Central Valley Barber College's daily crime log includes the nature, date, time, general location of each crime that occurs within the institution's Clery Geography, and the disposition of the complaint, if known.

Entries must be made within two business days of the report of the information, unless the disclosure is prohibited by law or would jeopardize the confidentiality of the victim. An institution may withhold this information if there is clear and convincing evidence that releasing it would jeopardize an ongoing criminal investigation or safety of the individual, cause the suspect to flee or evade detection, or result in the destruction of evidence. The school must disclose any withheld information once the adverse effect is no longer likely to occur. An institution is required to make the crime log for the most recent 60-day period open to public inspection during normal business hours. The school must make any portion of the log older than sixty days available within two business days of a request for public inspection.

As Central Valley Barber College does not have on campus housing, it does not file an annual security report.

## **Emergency Notifications & Timely Warnings**

Central Valley Barber College complies with **Emergency Notification**, and **Timely Warnings** as required by 34 CFR 668.46(g) – and for the safety of all staff and students.

Central Valley Barber College will use a text message warning system to immediately notify the campus community upon the confirmation of a significant emergency or dangerous situation involving an immediate threat to the health or safety of students or employees occurring on the campus.

The Central Valley Barber College considers a (1) significant emergencies or dangerous situations any included in the annual crime report, or anything considered ; (2) and will notify all staff and students (3) Central Valley Barber College will test the system no less than annually of the text notification system notification system.

In an emergency or a dangerous situation Central Valley Barber College will, without delay, send out an Emergency Notification, or Timely Warning unless such notification will compromise efforts to assist a victim or contain, respond to, or mitigate the emergency.

**Emergency notifications** are defined as an immediate notification to the campus community upon confirmation of a significant emergency or dangerous situation occurring on campus that involves an immediate threat to the health or safety of students or employees.

**Timely warnings** are defined as all Clery Act crimes that occur on Clery Geography that are reported to school or local police agencies and are considered by the institution to represent a serious or continuing threat to students and employees.

## Drug and Alcohol Abuse Prevention Program

This policy and training are for all enrolled regular students and staff members of Central Valley Barber College.

### Alcoholic Beverages:

The possession, sale, manufacture, or distribution of any controlled substance is illegal under both state and federal laws. Violators are subject to school disciplinary action, criminal prosecution, fine and imprisonment. It is unlawful to sell, furnish or provide alcohol to a person under the age of 21. The possession of alcohol by anyone less than 21 years of age in a public place or a place open to the public is illegal. It is also a violation of Central Valley Barber College's policy for anyone to consume or possess alcohol in any public or private area of its campus.

### Illegal Drugs and Financial Aid:

An important sanction under federal law is that persons convicted of any federal or state offense involving possession of a controlled substance are ineligible to receive any or all federal benefits (e.g., social security, student loans) for up to one year. If the offense involves distribution of a controlled substance, the guilty person could be ineligible for any or all federal benefits for up to 5 years. Any students convicted of possessing or selling illegal drugs while receiving Title IV assistance will be ineligible for FSA funds based on the following chart:

Central Valley Barber College prohibits the unlawful possession, use or distribution of illicit drugs and alcohol by students and staff on the campus or as part of any Central Valley Barber College activities.

The health risks of the use of illicit drugs and alcohol abuse require providing education and referral for students and staff. Central Valley Barber College provides education Central Valley Barber College and refers students and staff to local services, if needed or requested. Area drug abuse information, counseling and referral and treatment centers information is made available to students or staff members in the break room.

Central Valley Barber College will terminate students and staff involved in unlawful possession, use or distribution of illicit drugs and alcohol on campus according to the **school's conduct and termination policies for staff and student**. Students and staff may be reinstated upon completion of an appropriate rehabilitation program.

## **Health Risks**

Central Valley Barber College is committed to providing its students and employee's a drug and alcohol-free workplace and learning environment. Central Valley Barber College prohibits the unlawful possession, use manufacture, or distribution of unauthorized drugs and alcohol in the workplace, on the campus, or at any activities. Central Valley Barber College will provide a safe responsive environment for all students and employees.

Outlined below is a listing of drugs abuse and their health risks taken from the U.S. Drug Enforcement Administration website.

### **Alcohol**

Alcohol (beer, wine, or liquor) has a high potential for physical and psychological dependence as well as resulting in increased tolerance. Possible effects include impaired memory, slurred speech, drunken behavior, slow onset, vitamin deficiency, and organ damage. Overdose may result in vomiting, respiratory depression, loss of consciousness, and possible death. Withdrawal may include trembling, anxiety, insomnia, vitamin deficiency, confusion, hallucinations, and convulsions.

Females who drink alcohol during pregnancy may give birth to infants with Fetal Alcohol Syndrome. These infants have irreversible physical abnormalities and mental retardation. In addition, research indicates that children of alcoholic parents are at greater risk than other youngsters of becoming alcoholics. Alcohol use is often related to acquaintance rape and failure to protect oneself from sexually transmitted diseases (STDs). Additionally, alcohol-related accidents are the number one cause of death in the 16-24-year-old age group.

Narcotics (including heroin, morphine, hydrocodone, oxycodone, codeine, and others) have a high potential for both physical and psychological dependence as well as resulting in increased tolerance. The possible effects of using narcotics include euphoria, drowsiness, respiratory depression, constricted pupils, and nausea. Overdose may result in shallow breathing, clammy skin, convulsions, coma, and death. Withdrawals may include irritability, tremors, panic nausea, chills, and sweating.

### **Other Depressants**

Other depressants (including GHB or liquid ecstasy, valium, Xanax, Ambien, and barbiturates) have a potential for both physical and psychological dependence as well as resulting increase tolerance. The possible side effects include slurred speech, disorientation, appearance of intoxication, and impaired memory. Overdose may result in shallow respiration, clammy skin, dilated pupils, weak and rapid pulse, coma, and possible death. withdrawal may include anxiety, insomnia tremors, delirium, convulsions, and possible death.

### **Stimulants**

Stimulants (including cocaine, methamphetamine, and methylphenidate) have a possible risk of physical and psychological dependence. Tolerance can develop in all stimulants. The possible side effects include increase alertness, excitation, euphoria, increased pulse rate and blood pressure, insomnia, and decreased appetite. Overdose may result in agitation, increased body temperature, hallucinations, convulsions, and possible death. Withdrawal may result in apathy, long periods of sleep, irritability, depression, and disorientation.

**Hallucinogens**

Hallucinogens (including MDMA, LSD, Phencyclidine, and others) are less likely to result in physical dependence, with the exception of phencyclidines and analogs, and vary in terms of psychological dependence, ranging from non to moderate (MDMA) to high (phencyclidine and analogs). Tolerance can develop. Possible side effects include heightened senses, teeth grinding, and dehydration (MDMA and analogs) and hallucinations, altered perception of time and distance in other types of hallucinogens. Overdose may result in increased body temperature and cardiac arrest for MDMA and more intense episodes for LSD. Some hallucinogens may result in muscle aches and depression when in withdrawal (MDMA) or may result in drug seeking behavior.

**Cannabis**

Cannabis includes marijuana, tetrahydrocannabinol (THC), and hashish or hashish oil. It may result in moderate psychological dependence with THC resulting in physical dependence. Tolerance can develop in all forms. Possible effects include euphoria, relaxed inhibitions, increased appetite, and disorientation. Overdose may result in fatigue, paranoia, and possible psychosis. Withdrawal may occasionally result in insomnia, hyperactivity, and decreased appetite.
